Public Comment: Matt Lincoln, West Michigan Trails & Greenways Corporation-We are fundraising and looking for Township support in the form of a resolution as we work towards getting all of the White Pine Trail paved. Fred Meijer gave \$500,00.00 for the first phase. Phase one will pave 11.8 miles from Leroy to Reed City. It will cost 6 million dollars to pave from Big Rapids to Sand Lake. We have almost raised all the money that we will need for this part of the project. We are asking for a Resolution in favor of paving the trail by the Township with a copy of your minutes.

Minutes: Moved by Carolyn Towsley, supported by Sandra Mayo to accept the minutes with a correction to: Underages and Overages, should read "for tax payments and to not collect for any amount that is \$5.00 and below." Motion carried.

Financial Report: Moved by Sandra Mayo, supported by Kenneth Vredenburg to accept the Financial Report as given subject to audit. Motion carried. The Property Tax money has been deposited. The CD that expires on April 12<sup>th</sup> will be renewed. We can only deposit into it once a year. \$153.07 was carried over to the new Fiscal Year. There is \$150.33 in petty cash. There are two checks to Julie Jankowski because we discovered that we had missed one quarterly check to her this past year.

Payment of the Bills: Moved by Carolyn Towsley, supported by John Brockway to pay the Steve Lobart Law Office the \$125.00 (check#9023) fee for preparing the Quit Claim Deed, and \$30.00 (check #9024) to Kenneth Vredenburg for registering the deed, and to pay the Township check #'s 8986-9024 and the Cemetery check #'s 1579-1581. Motion carried.

Unfinished Business:

- Fire Department and First Responder Report: Fire runs are up. The Fire Department needs three sets of turn-out gear. The old models have been discontinued, and the new sets are more expensive. With shipping the cost will be \$5,478.24. Three firefighters have completed Company Officer 1&2. The Gear washers and dryers have been ordered to arrive after April 1<sup>st</sup>. \$6,500 was approved for the washer. The actual cost is going to be \$6,897. \$1,700 was approved for the two dryers. The actual cost is going to be \$1,799.
- 2. Assessor and Supervisor Report: Three people came to the Board of Review. The Cemetery Board Meeting is Thursday, April 20, 2017 at the Fire Hall at 7:00 p.m. Clean-up at the Stanwood Cemetery is April 24<sup>th</sup> with an alternate date of April 27<sup>th</sup>. The Verizon cell tower is up on 140<sup>th</sup>. There is a retirement open house for Joyce Randall. 8 Mile is still unfinished. No gravel has been put down yet.
- 3. Treasurer's Report: The CD account that expires today, April 12<sup>th</sup> will be renewed. We can only deposit in it once a year.
