## **Public Comment:**

- 1. Kaitlyn Haner-Intern at Mecosta County District Health Department #10 was unable to conduct a personal survey. There will be a Survey Monkey link available.
- 2. Tom O'Neil-Mecosta County Commissioner 5<sup>th</sup> District: The feedback from potential pathologists is that they would need to be paid by only one county. That county can work out a reimbursement system with the other counties. The Morgue Authority approved the suggestion and the County Commissioners approved it. The Dog Officer is resigning and going to work for the DNR. The dog will remain with him and his family. They are generally one-person dogs. The Sheriff's Department will not try to replace the dog until after the marijuana vote in November.
- 3. Stephanie McNeil-Morton Township Clerk: Morton Township is offering a 3-year proposal that would start on September 1, 2018. The base charge would be \$20,000/year. There would be a graduated fee per each fire run from \$500.00-\$1,500.00 according to the type of run. Eric Williams is attorney for both townships and would be willing to draw up the contract. Moved by Carolyn Towsley, supported by Sandra Mayo to begin contract agreement negotiations for Contracted Services for Fire Protection with Morton Township. Motion carried.

Minutes: Moved by Sandra Mayo, supported by John Brockway to accept the minutes as presented. Motion carried.

Financial Report: There is a 0.10 difference in the settlement that the Clerk and Treasurer will be resolving. We have received the Metro Act disbursement. Their online portal is still not working. The Financial Report is accepted subject to audit.

Payment of the Bills: Moved by John Brockway, supported by Sandra Mayo to approve for payment Township check #'s 9305-9325, and Cemetery check #'s 1611-1613. The bill for the audit will be paid after we receive clarification about the split between the Township and the Cemetery. Motion carried.
