2018 WINTER TAX BILL

IF YOUR BILL HAS A MORTGAGE CODE IN UPPER LEFT CORNER OF BILL, A COPY OF THIS TAX BILL HAS BEEN SENT TO YOUR MORTGAGE COMPANY. THE ORIGINAL TAX BILL, BY LAW, MUST GO TO THE PROPERTY OWNER FOR THEIR RECORDS.

If you desire a receipt, a self-addressed stamped envelope MUST be included with your payment. Payments are to be received in the township offices by 5:00 p.m. on <u>February 14, 2019</u> to avoid interest and penalty charges on winter taxes. <u>1% INTEREST plus 3% PENALTY CHARGE BEGINS FEBRUARY 15, 2019.</u> You can call the Treasurer for penalty amount.

DOG LICENSING

- 1. It is a law in the State of Michigan that if you have a dog, you MUST get that dog licensed.
- 2. Licensing dogs makes it easier for owners to be reunited with their stray or hurt dog.
- 3. A license shows that the dog has been vaccinated against rabies, which helps in protecting the community.
- 4. Dog licenses are available to be purchased every year or every 3 years.
- 5. To be able to purchase a license, you must have proof of rabies vaccination and to receive the unsexed fee, you must have proof of neutralization.
